***SPECIAL CONDITION:*** *MS State Law requires that male applicants between the ages of eighteen (18) and twenty-six (26) submit satisfactory documentation of their compliance with the draft registration requirements of the Military Selective Service Act with application. In addition, males between the ages of eighteen (18) and twenty-six (26) who are currently employed shall not be promoted to higher positions until they submit documentation of compliance with the requirements of the Federal Selective Service Act.*

**MINIMUM QUALIFICATIONS:**

**SUBSEQUENT TO JOB OFFER AND PRIOR TO JOB PLACEMENT, INDIVIDUAL WILL COMPLY WITH A PREPLACEMENT BASELINE PHYSICAL EXAMINATION AS IDENTIFIED IN NFPA 1582, 1581 and DOD PHYSICAL FITNESS REQUIREMENTS.**

1. High school graduate or GED equivalent. Minimum age 18 years old.
2. At least one (1) year experience as a full-time paid civilian/military firefighter. Eighteen (18) months continuous military service as a traditional guardsman/reservist in Fire Protection is considered equivalent to one (1) year full-time paid civilian/military experience.
3. Possess a valid state driver's license and if authorized to operate a government vehicle, have the ability to obtain and maintain a U.S. Government Motor Vehicle Operator's ID card. **PROOF OF DRIVER'S LICENSE MUST BE SUBMITTED WITH APPLICATION.**
4. **Must currently have the following DOD Certifications accredited by International Fire Service Accreditation Congress (IFSAC) or National Professional Qualifications Board (NPQB): PROOF OF CERTIFICATIONS MUST BE SUBMITTED WITH APPLICATION.**
  - (a) Fire Fighter I and II
  - (b) Hazardous Materials Awareness/Operations
  - (c) **The following "Certifications must be obtained within 18 months of placement into the position." "Failure to obtain the required certifications will be sufficient cause for demotion or removal from employment." (AFI 32-2001, ANG SUP I)**
  - (d) Airport Firefighter
  - (e) Driver Operator Pumper/ARFF/Water Tender
5. Additional requirements will be found in AFI 32-2001, ANG SUP I and local Operating Instructions/Procedures.
6. Requires physical dexterity in climbing and maneuvering around high and tight places.
7. Must be able to obtain a favorable National Agency Check (NAC).

**DUTIES AND RESPONSIBILITIES:** (Not all inclusive, will be fully explained during interview)

1. As directed by a crew chief/fire fighter of superior rank/grade, drive/rides a fire/crash/rescue vehicle to actual and potential emergencies, cleans station, washes vehicle and other vehicles.
2. Operates the pumping system, maintains the agent pressure at a desired level.
3. Functions as a rescue/nozzleman as directed by a crew chief/senior firefighter.
4. Must have a working knowledge of building construction and materials.
5. Provides and receives instructions both in the classroom and in practical demonstrations in the use of a variety of modern equipment and tactics.
6. As assigned, inspects such equipment as fire hydrants, performs facility pre-fire planning/inspections, fire extinguishers, vehicle, tools, test hose, etc.
7. As assigned, accomplish station duties/maintenance IAW applicable operating instructions.
8. Incumbent will accomplish all fire protection related duties as directed by a crew chief/senior firefighter.
9. Performs other duties as assigned.
