Mississippi Fire Academy graduates who have successfully completed the following IFSAC or Pro Board Certification course(s) may submit an official transcript and copy of their certificates to Purdue University Global Admissions, along with all other required admissions paperwork and potentially receive the following credits in one of our PG fire science degree programs. Certifications must be current and completed after January 1, 1992, to be eligible for transfer credit. Purdue Global is on a quarter credit hour (QCH) system and all credits awarded will be in quarter credit hours. When more than a single credit recommendation is listed the credits will be awarded to the one option that best fits the students' degree need.

To avoid duplication of knowledge, multiple certifications within a single certification series cannot be combined. Credits will be applied to the highest level certificate only. For example, if a student has completed both the Fire Inspector I and Fire Inspector II on his or her transcript the student will have Fire Inspector II applied toward potential credits. Whereas if a student has Fire Inspector II and Fire Officer III on his or her transcript then these are considered separate series of certificates and both certificates can be applied toward potential credits.
